Resolution providing for the designation as a Historic Structure under Title 11 of the Code of Ordinances that certain structure known as the Fairhaven Church, located at 2415 Saw Mill Run Boulevard, block and lot number 138-B-291-0000-03, in the 32<sup>nd</sup> Ward, City of Pittsburgh.

WHEREAS, the City of Pittsburgh has duly enacted Title 11 of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

WHEREAS, The Board of Trustees of the Fairhaven United Methodist Church has nominated the Fairhaven Church (2415 Saw Millrun Boulevard) for designation as a Historic Structure; and

WHEREAS, the Historic Review Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the Historic Review Commission has voted to recommend that City Council DESIGNATE the Fairhaven Church (2415 Saw Millrun Boulevard) as a Historic Structure; and

WHEREAS, the City Planning Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has voted to recommend that City Council DESIGNATE the Fairhaven Church (2415 Saw Millrun Boulevard) as a Historic Structure; and

WHEREAS, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

WHEREAS, the Council of the City of Pittsburgh finds that the aforementioned building is a Historic Structure that should be preserved;

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PITTSBURGH AS FOLLOWS:**

**SECTION 1.** Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the building known as the Fairhaven Church, located at 2415 Saw Mill Run Boulevard, block and lot number 138-B-291-0000-03, in the 32<sup>nd</sup> Ward, City of Pittsburgh.
