Section 1. The Mayor is hereby authorized to issue and the City Controller to countersign Warrants in the total sum of \$3,775,000.00, payable as follows: in favor of Thomas Doswell and Neufeld Scheck & Brustin, LLP in the sum of \$963,333.33; and \$295,000.00 to Liberty Life Assurance Company of Boston, for year 2010, the first year of three years of payments, all three payments of which are in full and final settlement of any and all claims filed in the United States District Court for the Western District of Pennsylvania, at No. 07-cv-0761, and charge the same to Code Account 46, Index Code 004606, Fund 1000, Sub 170, Account 582200, Org. 999200, Budget Year 2010. The following four additional Warrants are to be charged to the same Account, with the 2011 payments to be charged to Budget Year 2011, and the 2012 payments to be charged to Budget Year 2012.
