Resolution amending Resolution No. 288, effective May 22, 2006, entitled "Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant in the amount of \$6,500,000 for the August Wilson Center for African American Culture" by increasing the grant to ~~\$9,100,000~~ **\$9,450,000**. (Council District 6)

Whereas, by Resolution No. 288, effective May 22, 2006, the Council of the City of Pittsburgh authorized Urban Redevelopment Authority of Pittsburgh ("URA") to submit an application to the Commonwealth of Pennsylvania Office of the Budget (the "Commonwealth") for a grant under the Redevelopment Assistance Capital Program ("RACP") in the amount of \$6,500,000 for the August Wilson Center for African American Culture (the "Project"); and

Whereas, the Commonwealth has increased the grant to ~~\$9,100,000~~ **\$9,450,000**, which requires an amendment to Resolution No. 288 to reflect the increased grant;

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Section 1 of Resolution No. 288, effective May 22, 2006, which currently reads as follows:

“The Urban Redevelopment Authority of Pittsburgh is hereby authorized to file an application with the Commonwealth of Pennsylvania Office of the Budget for a grant under the Redevelopment Assistance Capital Program in the amount of \$6,500,000 for the Project.”

is hereby amended to read as follows:

“The Urban Redevelopment Authority of Pittsburgh is hereby authorized to file an application with the Commonwealth of Pennsylvania Office of the Budget for a grant under the Redevelopment Assistance Capital Program in the amount of ~~\$9,100,000~~ **\$9,450,000** for the Project.”
