*WHEREAS*, the General Assembly of the United Nations on December 22, 2008, adopted a resolution, drafted by the Democratic Republic of Congo, to recognize June 19<sup>th</sup> as World Sickle Cell Day, on June 19<sup>th</sup> of each year - starting in 2009 - which raises awareness that sickle cell disease as a serious world health problem;

*WHEREAS*, Sickle cell disease (SCD) affects millions of people throughout the world and is particularly common among those whose ancestors came from sub-Saharan Africa; Spanish-speaking regions in the Western Hemisphere (South America, the Caribbean, and Central America); Saudi Arabia; India; and Mediterranean countries such as Turkey, Greece, and Italy; and,

*WHEREAS*, it is recognized that sickle cell disease is one of the world's widespread genetic diseases, that it has severe physical, psychological and social consequences for those affected and their families, and,

*WHEREAS*, sickle cell disease is the only genetic disease that is both rare and neglected; affecting approximately 100,000 individuals in the United States and millions worldwide, and,

*WHEREAS*, there is an urgent need to raise public awareness about sickle cell disease and to eliminate health disparities and stigma associated with the disease; and

*WHEREAS*, the Children's Sickle Cell Foundation, Inc. is a local community-based organization founded in 2002 as an organization for families by families to engage, educate, and empower; and which has created and implemented programs such as: family support, family leadership, transition to adulthood, and educational support; and

**WHEREAS**, the Children’s Sickle Cell Foundation is celebrating its 20<sup>th</sup> Anniversary with a Benefit Gala to celebrate the impact the Children’s Sickle Cell Foundation has had in supporting children and adults who are “Living Well with Sickle Cell®”; and

**WHEREAS**, the Children’s Sickle Cell Foundation’s Benefit Gala will raise funds to support children and adults living with sickle cell disease and their families which include, but are not limited to - support for basic needs, transportation, education, wrap-around services, and research; and
