Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Deed by and between the Urban Redevelopment Authority of Pittsburgh and the City of Pittsburgh, in connection with the sale of Block 45-S, Lots 1 and 266, Block 45-L, Lots 11, 13, 14 and Block 46-N, Lot 106, in the 25<sup>th</sup> & 26<sup>th</sup> Wards of the City of Pittsburgh, for the sum of \$1.00, and

Whereas, the City of Pittsburgh has requested authorization to accept the aforementioned Deed; and
