Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 902.01.C, Zoning District Map No. 7 of the Pittsburgh Code is hereby amended so as to change from Grandview Public Realm Subdistrict B (GPR-B) to Grandview Public Realm Subdistrict A (GPR-B).
