Resolution amending Resolution 843-2023, authorizing the Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, to enter into an agreement or agreements and amendments thereto with Atlantis IT Consulting Group LLC as needed for an enterprise wide warehouse supply & inventory management solution by increasing the approved amount by \$540,000 for an amended total cost not-to-exceed Seven Hundred Seventy Thousand Dollars (\$770,000) over three years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 843-2023, “Resolution authorizing the Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, to enter into an agreement or agreements and amendments thereto with Atlantis IT Consulting Group LLC as needed for an enterprise wide warehouse supply & inventory management solution at a cost not-to-exceed Two Hundred Thirty Thousand Dollars (\$230,000) over one year” is hereby amended as follows:

Section 1. Resolution authorizing the Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, to enter into an agreement or agreements and amendments thereto with Atlantis IT Consulting Group LLC as needed for an enterprise wide warehouse supply & inventory management solution ~~at a cost not to exceed Two Hundred Thirty Thousand Dollars (\$230,000) over one year~~ **by increasing the approved amount by \$540,000 for an amended total cost not-to-exceed Seven Hundred**

Seventy Thousand Dollars (\$770,000) over three years.
