Ordinance amending Ordinance No. 32, effective 1-8-2008, entitled, "An Ordinance Amending and Supplementing the City Code, Title VII Business Licensing, by adding Article X Rental of Residential Housing, Chapter 781 Residential Housing Rental Permit Program" so as to extend the implementation date.

## Be it resolved that the Council of the City of Pittsburgh hereby enacts as follows:

**Section 1.** That Ordinance No. 32, effective January 8, 2008, entitled, "An Ordinance Amending and Supplementing the City Code, Title VII Business Licensing, by adding Article X Rental of Residential Housing, Chapter 781 Residential Housing Rental Permit Program, Section 781.09 Initial Implementation, is hereby amended as follows:

## CHAPTER 781 RESIDENTIAL HOUSING RENTAL PERMIT PROGRAM

Section 781.09 Initial Implementation

(a) Initial implementation shall begin no later than July 1, 2008 <u>December 1, 2008</u> in a manner determined by the City, but in any case all Rental Permit Registrations must be completed and paid in full no later than <u>September 30, 2008</u> <u>April 1, 2009.</u>
