Ordinance amending Ordinance No. 32, effective 1-8-2008, entitled, "An Ordinance Amending and Supplementing the City Code, Title VII Business Licensing, by adding Article X Rental of Residential Housing, Chapter 781 Residential Housing Rental Permit Program" so as to extend the implementation date.

Be it resolved that the Council of the City of Pittsburgh hereby enacts as follows:

Section 1. That Ordinance No. 32, effective January 8, 2008, entitled, "An Ordinance Amending and Supplementing the City Code, Title VII Business Licensing, by adding Article X Rental of Residential Housing, Chapter 781 Residential Housing Rental Permit Program, Section 781.09 Initial Implementation, is hereby amended as follows:

CHAPTER 781 RESIDENTIAL HOUSING RENTAL PERMIT PROGRAM
Section 781.09 Initial Implementation

- (a) Initial implementation shall begin no later than ~~July 1, 2008~~ **December 1, 2008** in a manner determined by the City, but in any case all Rental Permit Registrations must be completed and paid in full no later than ~~September 30, 2008~~ **April 1, 2009**.
