Ordinance amending the Pittsburgh Code, Title Nine, Zoning, Article I, Section 902.03 Zoning Map, by changing from RM-M, Residential Multi-Unit Moderate Density District; R1D-VL, Residential Single-Unit Detached Very Low Density District; and R1D-L, Residential Single-Unit Detached Low Density District; to EMI, Educational/Medical Institution District, certain property roughly bounded by Fifth Avenue, Murray Hill Avenue, Wilkins Avenue, and Woodland Road and identified as follows: Block Number 85-B, Lots Numbered 8 and 12; Block Number 85-F, Lots Numbered 103, 105, 107, 112, 142, 147, 148, 149, 150, 153, 155, 159, 249, and 250; Block Number 85-K, Lots Numbered 229, 232, 234, and 236; Block Number 85-L, Lot Numbered 281; Block Number 85-R, Lot Numbered 124; all in the Allegheny County Block and Lot System, 14th Ward.

## The Council of the City of Pittsburgh hereby enacts as follows:

Section 1. Amending the Pittsburgh Code, Title Nine, Zoning, Article I, Section 902.03 Zoning Map, by changing from RM-M, Residential Multi-Unit Moderate Density District to EMI, Educational/Medical Institution District, all that certain property identified as Block Number 85-B, Lots Numbered 8 and 12; Block Number 85-F, Lots Numbered 103, 105, 107, 112, 142, 147, 148, 149, 150, 153, 155, 159, and 249; all in the

Allegheny County Block and Lot System, 14th Ward.

## Section 2.

Amending the Pittsburgh Code, Title Nine, Zoning, Article I, Section 902.03 Zoning Map, by changing from R1D-VL, Residential Single-Unit Detached, Very Low Density District to EMI, Educational/Medical Institution District, all that certain property identified as Block Number 85-F, Lot Numbered 250; Block Number 85-L, Lot Numbered 200; and Block Number 85-R, Lot Numbered 124; all in the Allegheny County Block and Lot System, 14<sup>th</sup> Ward.

## Section 3.

Amending the Pittsburgh Code, Title Nine, Zoning, Article I, Section 902.03 Zoning Map, by changing from R1D-L, Residential Single-Unit Detached Low Density District to EMI, Educational/Medical Institution District, all that certain property identified as Block Number 85-K, Lots Numbered 229, 232, 234, and 236; and Block Number 85-P, Lot Numbered 281; all in the Allegheny County Block and Lot System, 14<sup>th</sup> Ward.
