## Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. That Resolution No. 288 effective, May 15, 2003, is hereby amended as follows:

"The Mayor and the Director of the Department of Engineering and Construction, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, or use existing Agreements, in form approved by the City Solicitor, with a Consultant or Consultants, for Architectural/Engineering Services in connection with various City projects at a cost not to exceed \$400,000.00 \$340,000.00 chargeable to the following account:
