Resolution amending Resolution No. 575, effective October 26, 2007, entitled "Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant in the amount of \$875,000 for the Pittsburgh Zoo Water's Edge and Multi Purpose Facility project" by increasing the grant to \$1,250,000. (Council District 7)

Whereas, by Resolution No. 375, effective October 26, 2007, the Council of the City of Pittsburgh authorized Urban Redevelopment Authority of Pittsburgh ("URA") to submit an application to the Commonwealth of Pennsylvania Office of the Budget (the "Commonwealth") for a grant under the Redevelopment Assistance Capital Program ("RACP") in the amount of \$875,000 for the Pittsburgh Zoo Water's Edge and Multi Purpose Facility project (the "Project"); and

Whereas, the Commonwealth has increased the grant to \$1,250,000, which requires an amendment to Resolution No. 575 to reflect the increased grant;

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution No. 575, effective October 26, 2007, which currently reads as follows:
