Resolution authorizing the Mayor and Director of the Department of Public Safety to execute relevant agreements to receive grant funding from the Pennsylvania Commission on Crime and Delinquency’s Gun Violence Reduction Initiative to add Operation Ceasefire outreach workers and provide training, and further providing for an agreement and expenditures not to exceed TWO HUNDRED FIFTY THOUSAND (\$250,000.00) dollars for this stated purpose.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Safety are authorized to execute relevant agreements with the Pennsylvania Commission on Crime and Delinquency in order to receive a grant award in the amount of TWO HUNDRED FIFTY THOUSAND (\$250,000.00) dollars to add Operation Ceasefire outreach workers and provide training. Monies from the grant agreement shall be deposited into the Grants Trust Fund account 2329400293.45505.00.

Section 2. The Mayor and the Director of the Department of Public Safety of the City of Pittsburgh are further authorized to enter into Agreements, or Contracts, or utilize existing Agreements or Contracts and not to exceed TWO HUNDRED FIFTY THOUSAND (\$250,000.00) dollars to add Operation Ceasefire outreach workers and provide training under the terms of the agreement between the City of Pittsburgh and the Pennsylvania Commission on Crime and Delinquency chargeable to and payable from the Grants Trust Fund account 2329400293.50000.00.
