Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Pittsburgh Code, Title Two: Fiscal, Article IX: Property Taxes, Chapter 267, Exemptions for Industrial and Commercial Improvements, is hereby amended as follows:
