Resolution authorizing a five-year Rooftop License Agreement between the City of Pittsburgh and 600 GS Prop LP at a cost not to exceed One Hundred Forty-Four Thousand Four Hundred Eleven Dollars And Sixty Cents (\$144,411.60).

**WHEREAS**, the parties have previously entered into a Rooftop License Agreement with 600 GS Prop LP whose term expired in May 2018; and

**WHEREAS**, the parties now wish to enter into a new such Rooftop License Agreement for a term of five years and expiring in May 2023 in order to further enhance the City’s digital video camera platform.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor, the Director of Innovation & Performance and Director of Public Safety are hereby authorized on behalf of the City of Pittsburgh to enter into a five-year Rooftop License Agreement or Agreements with 600 GS Prop LP at a total cost not to exceed ONE HUNDRED FORTY-FOUR THOUSAND FOUR HUNDRED ELEVEN DOLLARS and SIXTY CENTS (\$144,411.60), chargeable to and payable from the following accounts:
