## The 2010 Capital Budget total in City PAYGO funds - \$27,640,000.

Section 2 of Resolution No. 768, effective January 1, 2010, as amended, the Carnegie Library of Pittsburgh, a Pennsylvania nonprofit corporation (the "Library") is seeking to fill a gap of \$1.24 Million Dollars in their budget for 2010 or face the closure of various neighborhood branch Libraries, and as a condition of funding, the City Council shall require that all neighborhood branch libraries within the City of Pittsburgh remain open, and the Carnegie Library shall work with the City, the Regional Asset District Board, the State Legislature, local foundations and neighborhood community organizations to plan alternative funding to develop a permanent revenue stream as well as shared services plan to support the neighborhood branch system.
