Resolution providing for a three-party cooperation, reimbursement, and maintenance agreement or agreements by and among the City of Pittsburgh, the Stadium Authority of the City of Pittsburgh (the "Stadium Authority"), and the Pennsylvania Department of Transportation, in connection with the North Shore HOV entrance modification project.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into three-party cooperation, reimbursement, and maintenance agreement or agreements (Federal-Aid Project Agreements), each in form approved by the City Solicitor, by and among the City of Pittsburgh, Stadium Authority, and the Pennsylvania Department of Transportation, in connection with the implementation of North Shore HOV entrance modification project, situated in the 22<sup>nd</sup> Ward of the City of Pittsburgh, Council District No. 6, at the intersection of Reedsdale Street and Mazerowski Way.

**Section 2.** The City and Stadium Authority desire for Stadium Authority, acting as an agent for the City, to cause the said infrastructure improvements to be implemented at no cost to the City. Upon completion of the improvements, the City agrees to take over and maintain the street improvements in accordance with approved

drawings, as required by PennDOT/ Federal Highway Administration.

**Section 3.** Since the said infrastructure improvements are eligible for, and will receive, federal funding, PennDOT/ FHWA have agreed to channel all eligible reimbursements to Stadium Authority directly, subject to the City's agreeing to comply with the stipulations outlined in Section 2 above.

**Section 4.** Any Resolution or Ordinance or part thereof conflicting with the provisions of this Resolution is hereby repealed so far as the same affects this resolution.
