**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor is hereby authorized and directed to issue and the City Controller to countersign a warrant to pay over to the Commonwealth of Pennsylvania the sum of One Hundred and Thirteen Thousand, Fifty-nine Dollars and Twenty-three Cents (\$113,059.23) as follows:
