Resolution providing for a contract or contracts from time to time in connection with demolition and removal of condemned buildings and providing for the payment of the costs thereof. Cost not to exceed \$1,000,000.00.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Chief of the Bureau of Building Inspection, on behalf of the City of Pittsburgh, is hereby authorized to advertise for bids and to secure letter bids and to award a contract or contracts for the demolition and removal of condemned buildings at a cost not to exceed \$1,000,000.00 (one million dollars) chargeable to and payable from Neighborhood Stabilization Program Community Development Fund 5100, Organization 270000, Sub-Class PGHPR, Budget Year 2009, Project 2210011, Account 000000.
