## Be It Resolved by the Council of the City of Pittsburgh as follows:

**Section 1**. That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all of the City's right, title and interest, if any, in and to publicly-owned properties in the City of Pittsburgh designated in the Deed Registry Office of Allegheny County as follows:
