Resolution amending Resolution 21 of 2018, which will authorize the Mayor and the Director of Human Resources and Civil Service to extend the contract with The Standard Insurance Company for the administration of the City's Employee Leave Management Program, by changing JDE information to align with the contract legislation.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1.The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to extend the contract with The Standard Insurance Company for the administration of the City's employee Leave Management Program. The cost shall not exceed Five Hundred Twenty Thousand Dollars (\$520,000.00) over four years, subject to annual appropriation by City Council in future years.
