Whereas, pursuant to Ordinance No. 469, approved October 22, 1970, and in the manner prescribed by the Urban Redevelopment Law, Act of May 24, 1945, P.L. 991, as amended, the Redevelopment Proposal for Redevelopment Area No. 27 in the 21<sup>st</sup> Ward of the City of Pittsburgh was approved; and

Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and Dorse E. Moye, Brenda Moye and Ronald Moye, in connection with the sale of Block 22-K, Lot 35, for \$500.00, said property being located in the 21st Ward of the City of Pittsburgh; and
