Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor is hereby authorized and directed to issue and the City Controller to countersign a warrant to pay over to the Commonwealth of Pennsylvania the sum of Seventy-two Thousand, One Hundred and Ninety-five Dollars and Seven (*\$72,195.07*) as follows:
