This grant will be used in conjunction with department funds to execute contracts for an architectural inventory of historic structures in the city not to exceed fifty thousand (\$50,000) dollars.

Resolution authorizing the Mayor and the Director of City Planning of the City of Pittsburgh to accept a grant from the Pennsylvania Museum and Historical Commission in the amount of twenty-five thousand (\$25,000) dollars. This grant will be used in conjunction with department funds to execute contracts for an architectural inventory of historic structures in the city not to exceed fifty thousand (\$50,000) dollars.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of City Planning of the City of Pittsburgh are authorized to execute relevant agreements with the Pennsylvania Museum and Historical Commission in order to receive a grant award of twenty-five thousand (\$25,000) for the architectural inventory of historic structures in the City. The Grant Agreement shall be approved as to form and substance by the City Solicitor and monies shall be deposited into the account 11294000212.45505.00.

Section 2. The Mayor and the Director of City Planning of the City of Pittsburgh are further authorized to enter into an Agreement, or Contract, or utilize existing Agreements or Contracts, in a form approved by the City Solicitor and not to exceed twenty-five thousand dollars (\$25,000), for the architectural inventory of historic structures in the City under the terms of the agreement between the City and the Pennsylvania Museum and Historical Commission. Said agreement or agreements, contract or contracts, or expenditures shall not exceed twenty-five thousand dollars (\$25,000) chargeable to and payable from the Grants Trust Fund account 1129400212.50000.00.

In addition, The Mayor and the Director of City Planning of the City of Pittsburgh are further authorized to enter into an Agreement, or Contract, or utilize existing Agreements or Contracts, in a form approved by the City Solicitor and not to exceed twenty-five thousand (\$25,000) dollars cash match, for the architectural inventory of historic structures in the City under the terms of the agreement between the City and the Pennsylvania Museum and Historical Commission. Said agreement or agreements, contract or contracts, or expenditures shall not exceed twenty-five thousand (\$25,000) dollars chargeable to and payable from the 2017 operating budget account 11101.110000.53.53901.2017. The total amount of the contracts shall not exceed fifty thousand (\$50,000) dollars.
