Resolution providing for the conveyance by the City of Pittsburgh to Frank J. Valenta and Grandview Commons, LP, certain property in the 19th Ward, under Act No. 171 of 1984, entitled, "Second Class City Treasurer Sale and Collection Act", effective December 11, 1984.

WHEREAS: The City of Pittsburgh owns certain property at 109 Shaler Street, Block 6-G, Lot 67 in the 19th Ward.

WHEREAS: The City of Pittsburgh can only convey marketable title to both adjacent property owners.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The City of Pittsburgh ("City") is hereby authorized, through its appropriate officers and officials, to execute such documents and deed in form approved by the City Solicitor, and take all steps legally required to convey the following described property having been placed for sale by offering said property to adjoining property owners and the cost of the Court proceedings to be paid from Special Trust Fund, Three Taxing Bodies.
