**Section 1.** Section 1 of Resolution No. 584, effective October 12, 1998, which presently reads as follows:

Pittsburgh, are hereby authorized to enter into an Agreement or Agreements and contract or contracts, in a form approved by the City Solicitor, with a consultant or consultants and a vendor or vendors for various expenses in connection with the Pittsburgh Advocacy Commission on Youth in the Department of Parks and Recreation at a cost not to exceed One Hundred Twenty-Fifty Thousand One (\$125,001.00) Dollars, chargeable to and payable from Account 600000, Fund 2610, Organization 500000, Subclass C1993, Project/Grant 2248987, Budget Year 1997.

Is hereby amended to read as follows:

"The Mayor and the Director of the Department of Parks and Recreation, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements and contract or contracts, in a form approved by the City Solicitor, with a consultant or consultants and a vendor or vendors for various expenses in connection with the Pittsburgh Advocacy Commission on Youth in the Department of Parks and Recreation at a cost not to exceed (\$102,762.94), chargeable to and payable from Account 600000, Fund 2610, Organization 500000, Subclass C1993, Project/Grant 2248987, Budget Year 1997.
