Resolution amending Resolution No. 176, effective April 2, 2002 entitled "Authorizing the transfer of \$141,000.00 from the General Fund, City Clerk's Miscellaneous Services Account to the Department of Parks and Recreation's General Fund Grant Account for the purpose of implementing a portion of the 2002 City Council Grants Program" by increasing the amount \$13,500.00 \$14,000.00 from \$141,000.00 to \$154,500.00 \$155,000.00.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution No. 176, effective April 2, 2002 entitled "The City Controller is hereby authorized and directed to transfer \$141,000.00 from Fund 1000, City Clerk (Organization 101200), Miscellaneous Services (Subclass 150), Budget Year 2002, Account 526110, to Fund 1000, Parks and Recreation (Organization 500000), General Fund Grants (Subclass 300), Budget Year 2002, Account 566100" is hereby amended to increase the amount \$13,500.00 \$14,000.00 from \$141,000.00 to \$154,500.00 \$155,000.00.
