the 2019-2020 Community Development Block Grant Program at a cost not to exceed Four Million Five Hundred Fifty Eight Thousand Nine Hundred Sixty (\$4,558,960.00) Dollars, chargeable to and payable from the 2019 Community Development Block Grant Trust Fund as follows:
