Requesting the approval of an inter-municipal transfer of a restaurant liquor license, License No. R-1813, from Mama L's Pizza, 4536 Melwood Road, Leechburg PA, 15656, to Applicant M3K, Ltd., 3122 Chartiers Avenue, Pittsburgh, PA 15204, for the premises located at 3122 Chartiers Avenue, Pittsburgh, PA 15204, known as M3K, Ltd., t/a-Craig's Cocktails & Cuisine pursuant to amended Pennsylvania Liquor Code, §4-461.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-1813 from bankruptcy estate of Mama L's Pizza, 4536 Melwood Road, Leechburg PA, 15656, to Applicant M3K, Ltd., 3122 Chartiers Avenue, Pittsburgh, PA 15204, for the premises located at 3122 Chartiers Avenue, Pittsburgh, PA 15204, known as Craig's Cocktails & Cuisine pursuant to amended Pennsylvania Liquor Code, §4-461.

Section 2. Request for Approval

M3K, Ltd., which has a mailing address of 3122 Chartiers Avenue, Pittsburgh, PA 15204, submitted a request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-1813, which is currently registered to the bankruptcy estate of Mama L's Pizza, 4536 Melwood Road, Leechburg PA, 15656, desires to place a restaurant liquor license into premises known and numbered as Craig's Cocktails & Cuisine, 3122 Chartiers Ave., Pittsburgh, PA 15204. The proposed interior of the premises is a 1,500 square foot space with a seating capacity of 36, as a restaurant and tavern business.

Section 3. Public Hearing

City Council shall set a date for Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning Craig's Cocktails & Cuisine intent to the above liquor license.

Section 4. Approval or Denial of Request

After the Public Hearing which was held April 15, 2009, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of Craig's Cocktails & Cuisine, for inter-municipal transfer of a restaurant liquor license. City Council must approve Craig's Cocktails & Cuisine request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.
