Resolution amending Resolution No. 762, effective December 21, 2005, entitled: "Resolution providing for the filing of a Community Development statement by the City of Pittsburgh with the U.S. Department of Housing and Urban Development for a grant in connection with the 2006 Community Development Block Grant Program; providing for the execution of grant contracts and for the filing of other data providing for required assurances; providing for execution of payment vouchers on letter of credit and for certification of authorized signature; the deposit of the funds in a bank account and providing for the payment of expenses within categories;" so as to reprogram funds from Human Relation Commission, Mayor's Office and Public Works to Public Safety from: "Commission Operations - Fair Housing"(-\$100,000.00); "Arlington New Housing" (-\$99,858.00); and "Traffic Signal Hardware Upgrade" (-\$20.06), and transfer these funds to "SCBA Equipment" (+\$199,878.06).
