Resolution requesting the approval of an inter-municipal transfer of restaurant liquor license, License No. R-7542 from M.H.P. Corporation t/a Benito's, Olympia Shopping Center, McKeesport, PA 15132 to Applicant Fifth Avenue Pub, LLC, 1010 Fifth Avenue, Pittsburgh, PA 15219 into the premises to be known as Fifth Avenue Pub pursuant to amended Pennsylvania Liquor Code, §4-461.

### **Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R- 7542 from M.H.P. Corporation t/a Benito's, Olympia Shopping Center, McKeesport, PA 15132 to Applicant Fifth Avenue Pub, LLC, 1010 Fifth Avenue, Pittsburgh, PA 15219 into the premises to be known as Fifth Avenue Pub pursuant to amended Pennsylvania Liquor Code, §4-461.

#### **Section 2.** Request for Approval

Applicant Fifth Avenue Pub, LLC,-which has the mailing address of 1010 Fifth Avenue, Pittsburgh, PA 15219, submitted a request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-7542, which is currently, registered to M.H.P. Corporation t/a Benito's, Olympia Shopping Center, McKeesport, PA 15132 desires to place restaurant liquor license into the premises known as Fifth Avenue Pub, LLC, 1010 Fifth Avenue, Pittsburgh, PA 15219. The proposed interior of the premises is to be used as a sports grill, bar and lounge.

#### **Section 3.** Public Hearing

City Council shall set a date for a Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning Fifth Avenue Pub, LLC, 1010 Fifth Avenue, Pittsburgh, PA 15219, intent to the above liquor license.

#### **Section 4.** Approval or Denial of Request

After the Public Hearing which was held September 19, 2012, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of Fifth Avenue Pub, LLC, 1010 Fifth Avenue, Pittsburgh, PA 15219, for inter-municipal transfer of a restaurant liquor license. City Council must approve the Fifth Avenue Pub request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.
