Resolution amending Resolutions No. 739 approved on November 27, 2012; To set dynamic enforcement hours for Area "CC" in the Southside Flats community pursuant to the establishment of a Parking Enhancement District (Council District #3).

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** As provided by the Pittsburgh City Code, Chapter 549, entitled "Residential Parking Permit Program," a parking management plan is adopted as follows:

For the Area bounded by: S. 10<sup>th</sup> Street, from Sarah Street to Freyburg Street; S. 11<sup>th</sup> Street, from East Carson Street to Mary Ann Street; S. 12<sup>th</sup> Street, from East Carson Street to Breed Street; S. 13<sup>th</sup> Street, from East Carson Street to Breed Street; S. 14<sup>th</sup> Street, from East Carson Street to Sarah Street; S. 15<sup>th</sup> Street, from East Carson Street and its terminus; S. 16<sup>th</sup> Street, from East Carson Street to Sarah Street; Sarah Street, from S. 10<sup>th</sup> Street to S. 17<sup>th</sup> Street; Roland Way, from S. 12<sup>th</sup> Street to S. 13<sup>th</sup> Street; Roland Street, from S. 15<sup>th</sup> Street to S. 17<sup>th</sup> Street; Freyburg Street, from 10<sup>th</sup> Street to 12<sup>th</sup> Street; Bradish Street, from S. 10<sup>th</sup> Street to S. 12<sup>th</sup> Street; Mary Ann Street, from S. 11<sup>th</sup> Street to S. 12<sup>th</sup> Street; Breed Street, from S. 12<sup>th</sup> Street; Enon Way, from Sarah Street to Breed Street; and Uxor Way, from Sarah Street to Breed Street.

That motorized vehicle parking shall be restricted to a two (2) hour time limit between the hours of 12:00 p.m. - 12:00 a.m., Monday through Saturday except where existing parking restrictions may exist and vehicles displaying a valid Area "CC" residential permit or visitor's pass; and that residential parking permits be sold only to legal residents or a person who owns or leases commercial property and is actively engaged in a business on property fronting or abutting the above mentioned streets; and that visitor's pass usage shall be limited to no more than three consecutive weekdays on the same vehicle.

## IS HEREBY AMENDED TO READ AS FOLLOWS:

**Section 1.** As provided by the Pittsburgh City Code, Chapter 549, entitled "Residential Parking Permit Program," a parking management plan is adopted as follows:

Motorized vehicle parking shall be restricted to a two (2) hour time limit between the within the hours of 12:00 p.m. - 12:00 a.m. dynamic enforcement hours set by the Director of Finance, Monday through Saturday and 12:00 a.m. through 2:00 a.m. on Sunday except where existing parking restrictions may exist and motor vehicles displaying a valid area "CC" residential permit or visitor's pass; and that residential parking permits be sold only to legal residents or a person who owns or leases commercial property and is actively engaged in a business on property fronting or abutting the above mentioned streets; and that visitor's pass usage shall be limited to no more than three (3) consecutive days a month on the same vehicle.
