Resolution amending Resolution No. 90 effective March 3, 2003, entitled: "Providing for an Agreement or Agreements, with various community organizations for operational/administrative expenses, maintenance, purchase of equipment and/or rehabilitation of neighborhood facilities for the benefit of residents of the City of Pittsburgh and further, authorizing various departments to enter into contract or contracts or use existing contract or contracts for the purchase of equipment and/or furniture at a cost not to exceed \$1,489,000.00" so as to reprogram funds from WESTGATE VILLAGE RESIDENTS COUNCIL (-13,300) and WESTGATE VILLAGE/FAIRYWOOD FOOD BANK (- 6,000) to WEST PITTSBURGH PARTNERSHIP (+ 11,100); MW CDC-DUQUESNE HEIGHTS (+ 5,100); and BREACHMENDERS (+ 3,100); and from BROOKLINE SR.
