Resolution amending Resolution No. 332 of 2021 entitled "Resolution authorizing the Mayor and Director of the Department of Mobility and Infrastructure to apply for grant funding from the Pennsylvania Department of Conservation and Natural Resources' Community Conservation Partnerships Program to provide funding for the Three Rivers Heritage Trail Repaving Project" to accept the grant and authorize necessary expenditures

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution No. 332 of 2021, entitled "Resolution authorizing the Mayor and Director of the Department of Mobility and Infrastructure to apply for grant funding from the Pennsylvania Department of Conservation and Natural Resources' Community Conservation Partnerships Program to provide funding for the Three Rivers Heritage Trail Repaving Project" is hereby amended as follows:

Section 1. The Mayor and Director of the Department of Mobility and Infrastructure are authorized to ~~apply for~~ **receive** grant funding from the Pennsylvania Department of Conservation and Natural Resources' Community Conservation Partnerships Program to provide funding for the Three Rivers Heritage Trail Repaving Project **in the amount of ONE HUNDRED TWELVE THOUSAND NINE HUNDRED (\$112,900.00) dollars.** ~~The total project cost is \$200,000.00. The grant proposal includes an ask of \$112,988.70 with a local match of \$112,988.70 to come out of the 2021 City of Pittsburgh Capital Budget (JDE job number 6090000121).~~ **Monies from the grant agreement shall be deposited into the Grants Trust Fund 6029400379.45505.00.** ~~In the event the grant is awarded, this resolution provides for an agreement and expenditures not to exceed TWO HUNDRED TWENTY FIVE THOUSAND NINE HUNDRED SEVENTY SEVEN DOLLARS AND FORTY CENTS (\$225,977.40) for this stated purpose.~~

Section 2. The Mayor and the Director of the Department of Mobility and Infrastructure of the City of Pittsburgh are further authorized to enter into Agreements, or Contracts, or utilize existing Agreements or Contracts for expenditures not to exceed **ONE HUNDRED TWELVE THOUSAND NINE HUNDRED (\$112,900.00) dollars** for the Three Rivers Heritage Trail Repaving Project under the terms of the agreement between the City of Pittsburgh and the Pennsylvania Department of Conservation and Natural resources, chargeable to and payable from the appropriate expenditure account in the Grants Trust fund account **6029400379.**

Section 3. Local match of **\$112,900.00** shall come from the 2021 Capital Budget (JDE job number 6090001521) for a total project cost of **TWO HUNDRED TWENTY FIVE THOUSAND EIGHT HUNDRED (\$225,800.00) dollars.**
