Resolution amending Resolution 35 of 2023, which authorized the Mayor and the Director of the Department of Human Resources and Civil Service to enter into an Intergovernmental Cooperation Agreement or Agreements with the County of Allegheny and Partner4Work for the shared operation and administration of the 2023 Learn and Earn Summer Youth Employment Program, by increasing the total not to exceed amount by One Million Five Hundred Thirty-Six Thousand Fifty-Nine Dollars and Two Cents (\$1,536,059.02) for the 2024 program for a new total not to exceed Three Million Thirty-Six Thousand Fifty-Nine Dollars and Two Cents (\$3,036,059.02) over two years.

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 35 of 2023, entitled “Resolution authorizing the Mayor and the Director of the Department of Human Resources and Civil Service to enter into an Intergovernmental Cooperation Agreement or Agreements with the County of Allegheny and Partner4Work for the shared operation and administration of the 2023 Learn and Earn Summer Youth Employment Program in an amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000.00), and for the payment of the costs thereof” is hereby amended as follows:

Section 1. The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Cooperation Agreement or Agreements with the County of Allegheny and Partner4Work for the shared operation and administration of the 2023 **and 2024** Learn and Earn Summer Youth Employment programs. The City’s contribution under the Cooperation Agreement **or Agreements** shall not exceed ~~One Million Five Hundred Thousand Dollars (\$1,500,000.00)~~ **Three Million Thirty-Six Thousand Fifty-Nine Dollars and Two Cents (\$3,036,059.02)** to be paid from the following accounts:

\$1,500,000.00 from 11101.109000.58.58102.2023

\$1,500,000.00 from 11101.109000.58.58102.2024

\$36,059.02 from 0229400395.58102.00

Section 2. The authorized Intergovernmental Cooperation Agreement or Agreements shall be approved by the City Solicitor as to form.

Section 3. The final language of the Cooperation Agreement between the City of Pittsburgh, Allegheny County, and Partner4Work shall require the continuation of the Advisory Committee to monitor the 2023 **and 2024** Learn and Earn Summer Youth Employment Programs. The Advisory Committee will include a representative from City Council and a representative from the Department of Human Resources and Civil Service.
