Resolution amending Resolution 402, approved June 14, 2002, effective June 21, 2002 providing for an agreement or agreements with a Mockenhaupt Benefits Group to provide actuarial services for the CITY of Pittsburgh for a period of three years, for the years 2002 through 2004, at a cost not to exceed One Hundred Thousand Dollars (\$100,000) per year and providing for the cost thereof.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution 402 of 2002, which currently reads as follows:

The Mayor and the Director of Finance, on behalf of the CITY of Pittsburgh, are hereby authorized to enter into an agreement or agreements, in a form approved by the CITY Solicitor, with Mockenhaupt Benefits Group to provide actuarial services for the CITY of Pittsburgh for a period of three years, for the years 2002 through 2004, at a cost not to exceed One Hundred Thousand Dollars (\$100,000) per year subject to annual appropriation, chargeable to and payable from Fund 1000, Organization 107000, Subclass 150 Miscellaneous Services, Budget Year 2002, Account 526100.

Is hereby amended to read as follows:

The Mayor and the Director of Finance, on behalf of the CITY of Pittsburgh, are hereby authorized to enter into an agreement or agreements, in a form approved by the CITY Solicitor, with Mockenhaupt Benefits Group to provide actuarial services for the CITY of Pittsburgh for a period of four years, for the years 2002 through 2005, at a cost not to exceed One Hundred Thousand Dollars (\$100,000) per year subject to annual appropriation, chargeable to and payable from Fund 1000, Organization 107000, Subclass 150 Miscellaneous Services, Budget Year 2002, Account 525500.

Section 2. Section 2 of Resolution 402 of 2002, which currently reads as follows:

That the CITY Controller shall encumber funds for the 2002, 2003, and 2004 contract years from and subject to funds to be appropriated by CITY Council in the respective fiscal years in Fund 1000, Organization 107000, Subclass 150 Miscellaneous Services, Budget Year 2002, Account 526100.
