Resolution Amending Resolution 076-03, effective date Feb. 25, 2003, entitled Contracts for various Street Resurfacing Programs, by increasing the total funding by \$320,869.69, from Three Million Six Hundred Thousand Dollars (\$3,600,000.00), to ~~Three Million Nine Hundred Twenty Thousand Eight Hundred Sixty Nine Dollars Sixty Nine Cents (\$3,920,869.69).~~ \$3,920,791.54

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Res. 076-03, effective Feb. 25, 2003, which presently reads as:

The Director of the Department of General Services and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into a Contract or Contracts, or the use of existing Contracts in a form approved by City Solicitor, for street resurfacing programs to include but not limited, hot mix asphalt, crack sealing, equipment purchases, sawing and sealing, asphalt milling, truck rental, brick and blockstone repairs, handicap ramps, concrete slab replacement and parks related asphalt work throughout the City of Pittsburgh, at a cost not to exceed Three Million Six Hundred Thousand Dollars (\$3,600,000.00) chargeable to and payable from Fund 5100, Org. 400000, Sub-Class PGHPR, Project 2239000, Budget Year 2003, Account 525500, Citywide Resurfacing, Department of Public Works.

Is hereby amended to read as:

The Director of the Department of General Services and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to advertise for proposals and to award and enter into a Contract or Contracts, or the use of existing Contracts in a form approved by City Solicitor, for street resurfacing programs to include but not limited, hot mix asphalt, crack sealing, equipment purchases, sawing and sealing, asphalt milling, truck rental, brick and blockstone repairs, handicap ramps, concrete slab replacement and parks related asphalt work at various locations throughout the City of Pittsburgh, at a cost not to exceed ~~Three Million Nine Hundred Twenty Thousand Eight Hundred Sixty Nine Dollars Sixty Nine Cents (\$3,920,869.69),~~ \$3,920,791.54, chargeable to and payable from Fund 5100, Org. 400000, Sub-Class PGHPR, Project 2239000, Budget Year 2003, Account 525500, Citywide Resurfacing, Department of Public Works.
