**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 3.** If there is remaining funds in a trust fund after the funds authorized by this resolution have been transferred to the General Operating Fund, the City Controller shall inform the City Council so that additional legislation can be submitted as required.
