Resolution authorizing the execution of a cooperation agreement or agreements with the Urban Redevelopment Authority of Pittsburgh in which URA will make a \$100,000.00 grant to the City to pay part of the cost to convert Broad Street to two-way traffic. (Council District 9)

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Works are hereby authorized to enter into a cooperation agreement or agreements with URA, in form approved by the City Solicitor, pursuant to which Urban Redevelopment Authority of Pittsburgh ("URA") will make a grant to the City in the maximum amount of \$100,000.00 to be used by the City to pay part of the cost to convert Broad Street to two-way traffic.
