WHEREAS, the United States Constitution is the supreme law of our nation and this body has full confidence in its ability to endure all tests; and

WHEREAS, many immigrants came to the United States to escape government-sanctioned persecution of their faith; and

WHEREAS, Pittsburgh City Council believes that any law which is designed to restrict the liberty of one faith tradition erodes the founding principles of religious liberty and separation of church and state and that it is, as James Madison wrote in 1785, proper to "take alarm" at any such "experiment on our liberties"; and

WHEREAS, the Commonwealth of Pennsylvania has a history of embracing individuals' right to practice the faith tradition of their choice within the law and free from government interference; and

WHEREAS, a multiplicity of religious beliefs, traditions, and heritages brings strength to our city and state and it is not the role of the legislature of the Commonwealth of Pennsylvania or any state to disparage or marginalize any faith tradition; and

WHEREAS, the City of Pittsburgh benefits from a number of individuals and institutions whose faith motivates them to provide food to the hungry, shelter to the needy, inexpensive or free health services, and other humanitarian works; and

WHEREAS, religious leaders who facilitate conflict resolution often achieve judicially-sanctioned results that ease the burdens on our courts.
