BE IT FURTHER RESOLVED that the Council of the City of Pittsburgh, does hereby request that President Obama support troubled homeowners by fighting for a larger settlement with the Wall Street banks and
shepherding the passage of strong legislation and regulations that support across-the-board principal writedowns of underwater mortgages, and real negotiations between lenders and borrowers that result in modifications of the loan, including lowering interest rates and agreeing on affordable payments; and BE IT FURTHER RESOLVED that the Council of the City of Pittsburgh, does hereby call upon President Obama to urge the Department of Justice to aggressively pursue those servicing banks involved in the housing collapse, and that no misdeed or crime be left unpunished, and that adequate care be taken to ensure fair modifications to those facing foreclosure, establishing justice for homeowners and former homeowners across the Commonwealth of Pennsylvania and the United States.
