Resolution requesting the approval of an inter-municipal transfer of restaurant liquor license, License No. R-5232, from B & C Pizza, Inc., 998 Ardmore Blvd., Pittsburgh PA. 15221 to Applicant Tender Bar & Kitchen, LLC - 4300 Butler Street, Pittsburgh, PA 15201 into the premises to be known as the Tender Bar & Kitchen, pursuant to amended Pennsylvania Liquor Code, §4-461.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Council of the City of Pittsburgh hereby endorses the request for approval of an intermunicipal transfer of a restaurant liquor license, License No. R- 5232, from B & C Pizza, Inc., 998 Ardmore Blvd., Pittsburgh PA. 15221 to Applicant Tender Bar & Kitchen, LLC - 4300 Butler Street, Pittsburgh, PA 15201 into the premises to be known as the Tender Bar & Kitchen, pursuant to amended Pennsylvania Liquor Code, §4-461.

Section 2. Request for Approval

Applicant Tender Bar & Kitchen, LLC -which has the mailing address of 4300 Butler Street, Pittsburgh, PA 15201, Pittsburgh, PA 15201, submitted a request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-5232, which is currently, registered to B & C Pizza, Inc., 998 Ardmore Blvd., Pittsburgh PA, 15221 desires to place restaurant liquor license into the premises known as Tender Bar & Kitchen - 4300 Butler Street, Pittsburgh, PA, 15201. Section 3. Public Hearing

City Council shall set a date for a Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning Tender Bar & Kitchen, LLC - 4300 Butler Street, Pittsburgh, PA 15201, intent to the above liquor license.

Section 4. Approval or Denial of Request

After the Public Hearing which was held <u>September 19, 2012</u>, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of Tender Bar & Kitchen, LLC - 4300 Butler Street, Pittsburgh, PA 15201, for inter-municipal transfer of a restaurant liquor license. City Council must approve the Tender Bar & Kitchen request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.

NOTE: Pursuant to 47P.S. Sec. 4-461 (b.3.) Mayor's signature not required.
