Resolution amending Resolution # 338, Effective July 15, 2008, entitled: "Providing for an Agreement or Agreements with various community organizations for operational/administrative expenses, maintenance, purchase of equipment; and/or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the benefit of residents of the City of Pittsburgh", so as to transfer funds within the Mayor's Office from: "Better Block Development (-\$10,000.00), "Greenfield Organization (-\$5,000.00), "Homewood Brushton Athletic Association" (-\$10,000.00) and "Windgap-Chartiers Athletic Association (-\$5,000.00); and transfer these funds to the "Pittsburgh Action Against Rape" (+ \$30,000.00). Be it resolved by the Council of the City of Pittsburgh as follows:

Read and referred

**Section 1.** Resolution # 338, Effective July 15, 2008, which presently reads as follows:

The Mayor and the Director of City Planning, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, in a form approved by the City Solicitor, with the following various community organizations, for operational/administrative expenses, maintenance; and /or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the benefit of residents of the City of Pittsburgh, at a cost not to exceed 800,000.00, chargeable to and payable from the 2008 Community Development Block Grant Program and the listed code accounts in the Mayor's Office.
