#### **SECTION 1.**

The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-13064 from Max's Place, Inc. 322 Helen Street, McKees Rocks, PA 15136, to Applicant, Kassab's Restaurant, Inc. for the premises located, 1207 E. #### **SECTION 3**. Public Hearing

#### SECTION 4. Approval or Denial of Request

After the Public Hearing which was held 02-27-13, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of Kassab's Restaurant, Inc. for inter-municipal transfer of a restaurant liquor license. City Council must approve Kassab's Restaurant, Inc. request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.
