Resolution amending Resolution 740, effective December 4, 2012, entitled, Resolution requesting the approval of an inter-municipal transfer of restaurant liquor license," so as to change the license and name FROM: License No. R-6449, from Pintail Group, LLC, Monroeville Mall, Unit 300, Monroeville PA 15146, TO: License No. R-12461 from 316 6th Street, LLC, located at 316 6<sup>th</sup> Street, McKeesport, PA 15132 to Applicant TBM PA01, LLC, 204 Auila Road, West Palm Beach FL 33405; into the premises to be known as The Beer Market, 110 Federal St., pursuant to amended Pennsylvania Liquor Code, §4-461.

### Be it resolved by the Council of the City of Pittsburgh as follows:

#### Section 1. Resolution 740 of 2012 is hereby amended as follows:

"The Council of the City of Pittsburgh hereby endorses the request for approval of an inter-municipal transfer of a restaurant liquor license, License No. R-6449, from Pintail Group, LLC, Monroeville Mall, Unit 300, Monroeville PA 15146 License No. R-12461 from 316 6th Street, LLC, of 316 6<sup>th</sup> Street, McKeesport, PA 15132 to Applicant TBM PA01, LLC, 204 Auila Road, West Palm Beach FL 33405; into the premises to be known as The Beer Market, Boggs Building, 110 Federal Street, Pittsburgh PA 15222 pursuant to amended Pennsylvania Liquor Code, §4-461.

#### Section 2. Request for Approval

Applicant TBM PA01, LLC -which has the mailing address of 204 Auila Road, West Palm Beach FL 33405, submitted a request for

approval of an inter-municipal transfer of a restaurant liquor license, ~~FROM: License No. R-6449, from Pintail Group, LLC, Monroeville Mall, Unit 300, Monroeville PA 15146~~Which is currently, registered to Pintail Group, LLC, Monroeville Mall, Unit 300, Monroeville PA 15146 , **FROM: License No. R-12461 from 316 6th Street, LLC, of 316 6<sup>th</sup> Street, McKeesport, PA 15132 which is currently, registered to 316 6th Street, LLC, of 316 6<sup>th</sup> Street, McKeesport, PA 15132** desires to place restaurant liquor license into the premises known as The Beer Market, Boggs Building, 110 Federal Street, Pittsburgh PA 15222. The proposed interior of the premises is a restaurant business containing 7,101square feet of floor area.

### **Section 3. Public Hearing**

City Council shall set a date for a Public Hearing for the purpose of receiving comments and recommendations of interested individuals residing in the City of Pittsburgh concerning The Beer Market, Boggs Building, 110 Federal Street, Pittsburgh PA 15222, intent to the above liquor license.

### **Section 4. Approval or Denial of Request**

After the Public Hearing which was held November 20, 2012, and within 45 days of the introduction of this Resolution, City Council shall render a decision to approve or disapprove the request of The Beer Market, Boggs Building, 110 Federal Street, Pittsburgh PA 15222, for inter-municipal transfer of a restaurant liquor license. City Council must approve The Beer Market request unless it finds that approval would adversely affect the welfare, health, peace and morals of the City of Pittsburgh or its residents.
