Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to acquire all of the City's Right, Title and Interest, if any, in and to the Publicly-Owned Properties in the 12th Ward of the City of Pittsburgh Designated in the Deed Registry Office of Allegheny County as Block 83-M, Lots 208A, 208, 209, 211, 213, 215, 216, 217, 218, 219, 220; Block 124-J, Lots 86, 88, 88A, 89, 93, 94, 95, 97, 99, 100, 101, 102, 104, 104A, 105, 106, 107, 108, 110; and Block 124-N, Lots 125, 126, 127, 128 and 129 (Council District No. 9 - Site Assemblage for Residential Development - 8 Emans Way, 8, 10, 14, 18, 22, 24, 26, 28, 30, 32, 40, 44, 46, 43, 41, 39, 35, 31, 29, 27, 25 Carver Street; 2, 4, 8, 10, 14 Meadow Street; 307, 309, 311, 313, 315 Larimer Avenue; 30 Pace Way).

Whereas, the Urban Redevelopment Authority of Pittsburgh desires to acquire all of the City's right, title and interest, if any, in and to publicly-owned properties known as Block 83-M, Lots 208A, 208, 209, 211, 213, 215, 216, 217, 218, 219 220; Block 124-J, Lots 86, 88, 88A, 89, 93, 94, 95, 97, 99, 100, 101, 102, 104, 104A, 105, 106, 107, 108, 110; and Block 124-N, Lots 125, 126, 127, 128 and 129 in the 12th Ward of the City of Pittsburgh, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition.

Whereas, the Council of the City of Pittsburgh desires to give approval to the acquisition by Urban Redevelopment Authority of Pittsburgh.

## Be It Resolved by the Council of the City of Pittsburgh as follows:

Section 1. That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all of the City's right, title and interest, if any, in and to publicly-owned properties known as Block 83-M, Lots 208A, 208, 209, 211, 213, 215, 216, 217, 218, 219, 220; Block 124-J, Lots 86, 88, 88A, 89, 93, 94, 95, 97, 99, 100, 101, 102, 104, 104A, 105, 106, 107, 108, 110; and Block 124-N, Lots, 125, 126, 127, 128 and 129 in the 12th Ward of the City of Pittsburgh.

Section 2. That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and incidental expenses in connection with said acquisition.
