## Be it resolved that the Council of the City of Pittsburgh hereby enacts as follows:

**Section 1.** The Mayor is hereby authorized to issue and the City Controller to countersign a warrant to be issued in the amount of \$3,595.50 to Leech Tishman Fuscaldo & Lampl, 525 William Penn Place, 30<sup>th</sup> Floor, Pittsburgh, PA 15219, for mediation services in connection with a FLSA case, and charge the same code to 11101.53.53517.108000.2013.
