**WHEREAS,** UPMC has disrupted the continuity of patient care by shutting out Community Blue subscribers from its network, even if they would pay cash for services; and

**WHEREAS**, with a Pittsburgh tradition of standing up to bullies, the workers of UPMC are courageously standing up to the health care giant not just for themselves or their own families, but for all of us who work for a wage or salary in our society; and

WHEREAS, on September 7, 2013, UPMC workers will lead a rally and march to UPMC to demand that the
