Pursuant to Section 8 of the Policemen & Firemen Collective Bargaining Act (Act 111), the City is required to pay the expenses incurred in connection with the arbitration proceeding. **Be it resolved by the Council of the City of Pittsburgh as follows:**

Section 1.
