**Section 2.** East Liberty Development Inc shall use their funds for the purpose of hiring a consultant for the implementation and facilitation of projects, and for working with community groups on planning.

**Section 3.** East Liberty Development Inc shall use any other funds remaining after the hiring of a consultant for capital projects that are municipal in nature and directly relate to the public interests of the City of Pittsburgh. Allowable projects include public park improvements, community gardens, public building improvements, tree plantings, equipment to perform community enhancement activities, traffic studies, educational and community outreach, and public safety outreach.
